**Botetourt Deed Book 1, page 432:**

This Indenture made the twelfth day of September in the year of our Lord One Thousand Seven Hundred and Seventy Two between Israel Christian agent and Elizabeth his wife of the County of Botetourt and Colony of Virginia of the one part and Adam Looney of the same County and Colony of the other part. Witnesseth that the said Israel Christian for and in consideration of the sum of sixty-five pounds to him in hand paid by the said Adam Looney doth give, grant, bargain and sell unto the said Adam Looney and his heirs a certain tract or parcel of land containing one hundred and fifty acres lying and being on Stone Run, a branch of Craig's Creek and granted to him by patent the fourteenth day of July one thousand seven hundred and sixty nine and bounded as followth to wit: beginning at a white oak by a spring and running thence north thirty degrees west, forty eight poles to a black oak on a hill, thence north sixty degrees east ninety six poles to a black oak and a white oak on a hillside, north eighty degrees East, sixty poles to three hickory saplings, south eighty five degrees East one hundred and sixty four poles to two hickories, south fifty degrees East thirty four poles to a Synn in Bradshaws land and with the same South sixty poles across the \_\_\_\_\_ to two white oaks on a rise and thence along the same three hundred and seven poles to the Beginning, together with all its appurtenances to hae and to hold the said parcel of land with it appurtenances to the said Adam Looney and his heirs to the sale \_\_\_\_\_ and behoof of the said Adam Looney and his heirs. In witness where of the said Israel Christian and Elizabeth his wife have hereto subscribed their names and affixed their seals the day and year first above written.

**Botetourt County Court Deed Book 15, pages 364-365:**

Know all men by these presents that whereas in and by certain indentures of bargain and sale bearing date on the 10<sup>th</sup> of March 1822 and made between Peter Echols of the first part, Joseph Givens of the second part, and Michael Wrightman of the third part, the said Peter Echols for the considerations therein mentioned, did grant bargain and sell unto Joseph Givens, his heirs and assignees forever two lots in the town of Amsterdam, in the County of Botetourt, on the west end of Roan Oak Street, being numbers 77 and 78, with all their appurtenances, rights and priveleges in which said indenture of bargain and sale, I the said Joseph Givens, do hereby declare that my name was only \_\_\_\_\_ in trust for Michael Wrightman aforesaid, now know ye that I the said Joseph Givens in discharge of the said trust in the \_\_\_\_\_ as aforesaid, and at the request of the said Michael Wrightman hath re\_\_\_\_, released, surrendered, assigned and set over, and by thee presents do for me, my executors and administrators, freely and absolutely re\_\_\_\_, release, surrender, transfer and set over unto the said Peter Echols, his heirs, executors, administrators and assign all my right, title, interest, benefit, trust, claim and demand, whatsoever, which I the said Joseph Givens, my executors, administrators, can, shall or may have or claim of, in the said premises or to any promise or thing whatsoever in said indenture mentioned or \_\_\_\_\_, so that neither I the said Joseph Givens or my legal representatives, at any time hereafter, shall or write claim any property, title

or other thing, in any manner whatsoever by reason or means of the said Indenture or any covenant therein contained, but thereof and therefore, and of and from all actions, suits and demands which I or my legal representative, may have concerning the same, shall be forever barred by thee presents in witness and whereby I have hereunder set my hand and affixed my seal this 11<sup>th</sup> February 1823.
